"I have been refused the right to have a representative of my choice. I understand that I am being ordered to make a report or answer questions and that, if I do not comply with the order, I may be disciplined for insubordination.

Therefore, I have no alternative but to abide by the order. However, by so doing, I do not waive my constitutional rights to remain silent under the 5th and 14th amendments to the United States Constitution and under the protections afforded me under state law."

# Reeling From Loss, Supporting Those Who Serve

**2023 has begun with the loss of two heroes**

**H**ello, everyone from RSA; I hope this message finds you and your family

well. This message will serve as my January Presidents' Message and RSA's annual report as required by our Bylaws.

The start of 2023 has not been good. We began the year with the murders of Deputies Isaiah Cordero and Darnell Calhoun, the first non-COVID/medical deaths since 2003. While we are all still reeling from their murders, we sincerely appreciate the overwhelming public support we witnessed.

Deputy Isaiah Cordero, a deputy who was a ray of sunshine in the Riverside Sheriff's Department, was dedicated to protecting others. Once again, we face a tragic reminder of the selflessness and unwavering courage required of peace officers and their families. Deputy Cordero wore his uniform to make a difference in his community and keep families safe. His death leaves a tremendous hole in the hearts of many people who had the chance to know him personally. Deputy Cordero made the ultimate sacrifice in the line of duty — a debt that can never be repaid.

Deputy Darnell Calhoun answered the call to serve, defend and protect our community. Deputy Calhoun was a leader in community policing,

believed in people and his ability to speak to the community with respect; meet them where they are in life; try to understand their needs; and work together to find solutions to the issues they were facing. To Darnell, being a Police Officer in San Diego and Deputy in Riverside was about making the community a better and safer place for everyone.

## BUDGET

Your Board of Directors approved the 2022 RSA operating budget in November 2021, and during the course of 2022, monitored the budget and ensured the terms of the budget were followed. I am happy to report that the RSA ended the year within budget but was also able to do so while enhancing services to our membership. An essential part of reaching these accomplishments in 2022 was the RSA hiring of a full-time Member Services Director, Retired Deputy Juvien Galzote.

## MEMBER OUTREACH

Juvien helped us complete 14 Station visits with our RSA Rollin' Smokehouse and Chow Shack. In addition to providing excellent food during our station visits, the Smokehouse and Chow Shack helped support our members at 37 other member and community events. RSA also led an effort and raised money from the community to purchase an additional, completely donated smoker trailer to support our operations.

RSA staff also fielded over 300 labor-related questions during 2022 and filed six grievances, all were settled in favor of the member(s).

## CONTRACTS

RSA successfully worked with the County to make a mid-contract market adjustment, resulting in unexpected pay increases for our Probation Members. RSA also successfully had the new



hire meetings for Probation members return to being held at RSA.

For the first time in several years, RSA was able to settle MOU language with the County for Corrections and Law Enforcement Bargaining Units and made a lot of ground toward having a new MOU for Probation. RSA also added the County's Welfare Fraud Investigator's and Supervisors to the Law Enforcement Bargaining Unit.

**WORKERS COMP/  
MEDICAL PREMIUMS**

Another big move towards improving our service commitment to our membership was negotiating funding from the County to support a Worker's Comp/Wellness program through RSA that includes a Worker's Comp carve out. This will help improve the worker's comp experience for our members by providing them with a person to assist them through the process.

Your Benefit Trust, Trustees were also able to hold your medical premiums for the 11<sup>th</sup> year in a row. This means members' premiums are the exact cost as they were 11 years ago. In addition, the Trustee's were able to increase the amount paid into your VEBA to \$80.00 a month. Finally, the Trustees also implemented an almost no cost Body-scan for our members.

**POLITICAL ACTION**

Your RSA Political Action Committee was very active and had very successful campaigns, including some critical races like the Sheriff, District Attorney, and County Supervisors. This will ensure continuity with allies in the department and in the criminal justice system and the addition of Supervisors that support law enforcement and the RSA on the Board of Supervisors.

**WHAT YOU NEED TO  
KNOW ABOUT SB 2**

In part, California Senate Bill 2 (SB 2) establishes a process in which POST certificates can be revoked

for what is defined in the new law as “serious misconduct.” Under this law, the decertification means you would no longer be eligible to serve as a peace officer in the state.

Peace officers appointed to POST-certified agencies, which includes the Riverside Sheriffs' Department, are subject to these new regulations. The process, which includes public hearings and having the decisions published, *may affect* your civilian or military employment, businesses and other parts of your life. Even if you are exonerated and retain your certification, third parties will have had access to the proceedings.

**“SERIOUS MISCONDUCT” THAT CAN LEAD TO DECERTIFICATION**

While some of SB 2 went into effect last year, the decertification process went into effect on January 1, 2023. Officers will be subject to decertification for the following, defined as “*serious misconduct*”:

- Dishonesty relating to the reporting, investigation or prosecution of a crime or misconduct
- Abuse of power, including intimidating witnesses, false confessions and arrests
- Physical abuse, including excessive or unreasonable use of force
- Sexual assault, pursuant to PC §832.7
- Demonstrating bias, in violation of law, policy or inconsistent with peace officer duties

- Acts that violate the law and are sufficiently egregious or repeated
- Participation in a law enforcement gang
- Failure to cooperate with an investigation into potential police misconduct
- Failure to intercede in use of force

POST can take action against a certification for misconduct that occurred before January 1, 2022, for the following serious misconduct:

- Dishonesty
- Sexual assault
- Use of deadly force resulting in death or serious bodily injury

Or the employing agency makes the final determination regarding its investigation after January 1, 2022. As you can see, some of this language is vague and not fully defined, such as *unreasonable, abuse of power* and *sufficiently egregious*.

Misconduct that could render a peace officer subject to suspension or revocation must be reported to POST, including:

- Complaints, charges or allegations
- Findings or recommendations by a civilian oversight entity, including a civilian review board, civilian police commission, police chief or civilian inspector general



- The *final disposition* of any investigation reported under this section
- Any civil judgments or court findings or settlements of civil claims *based on allegations* of misconduct

Beginning January 1, 2023, agencies have until July 1, 2023, to report any event that occurred between January 1, 2020, and January 1, 2023.

**OVERVIEW OF THE DECERTIFICATION PROCESS**

SB 2 establishes a new division to review cases for peace officer decertification: the Peace Officer Standards Accountability Division. The new division will not have the infrastructure to be an internal affairs-type of operation. The primary responsibility for investigating will remain with the officer's agency. As per the illustration below, there is a step-by-step process for decertification, which begins with a division review.

If the division concludes there are reasonable grounds for decertification, the process will continue to each step unless it is stopped at any step. It includes an evidentiary hearing by an administrative law judge (ALJ) and ends with a second commissioners' hearing.

One step in the process is a review by the new nine-member advisory board, set up to give a voice to those in the community involved with "police accountability." Only two of the nine members on this board can have any peace officer experience. Perhaps the

most controversial part of this board is that two members are to be appointed with "strong consideration given to individuals who have been subjected to wrongful use of force likely to cause death or serious bodily injury by a peace officer, or who are surviving family members ...."

One of the myths is that this board will have the power to counter POST commissioners' findings that would exonerate an officer. Looking ahead to 2023, your Board of Directors has set three regular Board Meetings in the Desert at our east office, so it will be easier for our east-end members to attend the Board meetings

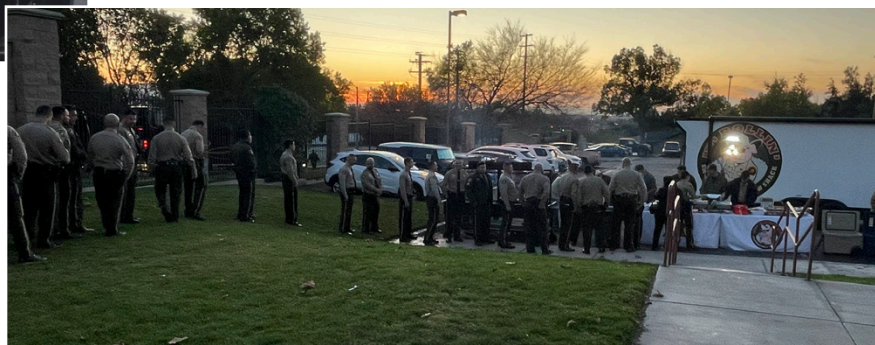
# In Memory Of Deputy Isaiah Cordero

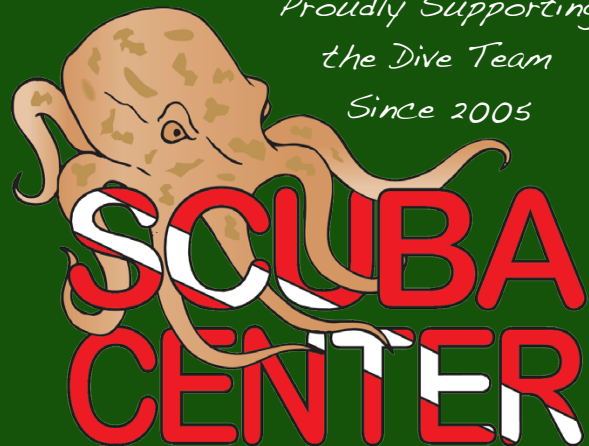

# Riverside County's Capitol Clout Climbs

**E**arlier this month, legislators returned to Sacramento to begin their 2023-2024 session in earnest.

They've been introducing bills and preparing their analyses of the governor's just-released proposed state budget.

The budget documents outline the spending priorities of his administration. The legislature uses the proposal as a starting point for negotiations that will ultimately conclude in June when the budget bill must be enacted. Throughout these discussions, lawmakers can make requests to support their own priorities in hopes of securing state dollars back to fund local programs, services and projects in their districts.

Each year, the various budget committees and subcommittees of the Assembly and Senate hammer out their spending plans in consultation with each other and the administration. It is in policy-specific sub-committees where the bulk of this work is completed.

Importantly, the four state Senators representing Riverside County have been assigned to the Senate Budget Committee. The interests of Riverside County residents should be well-represented as the legislature begins to consider and amend the governor's proposed state budget for the 2023-2024 fiscal year that will begin July 1.

In a sign that the importance of the Riverside County legislative delegation is being recognized by legislative

leaders, every state lawmaker from our county has been selected to serve as either a chair or vice chair of at least one committee, with four representatives serving in leadership positions on multiple committees.

As this article went to print, the Assembly had only announced the committee chairs and vice chairs assignments as well as the membership of the Assembly Rules Committee. Assembly committee assignments, including their budget committee and sub-committee members are expected to be released before the end of January.
