- Please provide dependent substantiation documents to the Benefits Office when requested to avoid cancellation of your dependent's coverage.

## RSA Legal Defense Alert!!

Always consult with an association representative/lawyer before responding to any report, letter, memo and/or questions concerning an investigation that could possibly lead to punitive action. If ordered to do so, ask to have it recorded and read the following: Non-waiver statement

"I have been refused the right to have a representative of my choice. I understand that I am being ordered to make a report or answer questions and that, if I do not comply with the order, I may be disciplined for insubordination.

Therefore, I have no alternative but to abide by the order. However, by so doing, I do not waive my constitutional rights to remain silent under the 5th and 14th amendments to the United States Constitution and under the protections afforded me under state law."

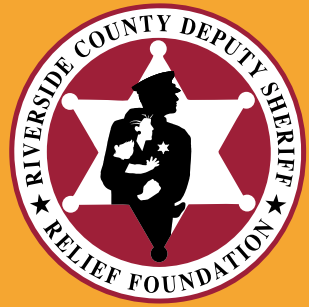

# EXECUTIVE ORDER N-62-20

## COVID-19 Work Caused Presumption

**C**alifornia Governor Gavin Newsom issued an Executive Order N-62-20 on 05/06/2020 that if an employee develops COVID-19 illness shall have the benefit of a presumption that the illness is work caused.

The presumption can be rebutted if certain elements are not there. (1) The diagnoses of CV-19 are within 14 days of the worker performing work at the work site per employer's direction. (2) The work done at the place of employment was on or after 03/19/2020. (3) The workers location of employment was not at the worker's home. (See 1 & 2) (4) The diagnosis of CV-19 is made by a California licensed physician or surgeon; and, the diagnosis is confirmed a second time within 30 days of the first diagnosis of CV-19.

Again, the presumption can be rebutted if the various elements are not there or developed. There is another presumption if after the employer receives notice of the claim and if they do not deny same within 30 days of employers' knowledge it can be presumed the CV-19 is job-related.

There are some **DISTINGUISHABLE PAYMENTS** that are different from other Workers' Compensation injuries. The Order states the worker has to use their own sick leave benefits. Also, the injured

worker needs to be certified and re-certified 15 days after the diagnosis then, after, recertified every 45 days for Temporary Disability or 4850 benefits. The doctor providing the certification shall be, again, California licensed either a physician or surgeon previously designated from the employer Medical Provider List, or a doctor from employee's health plan. If the employee does not have a designated Workers' Compensation doctor or a group health plan the worker can select his/her own doctor. There are certain elements that must be established by the worker, if not the employer will have the power to deny the COVID-19 case.

The Government Code identifies a special area called "California Emergency Service Act". This Legislation was created to deal with situations such as the Corona Virus attack on our population.

Pursuant to §8566 the Governor has the power to expand appropriations for support of the California Emergency Services Act. The code also indicates consideration will be given to the plans of the Federal Government in preparing the State's Orders and Regulations. These Orders and Regulations are tools that the Executive Branch can utilize in the event of a State of Emergency, which we currently have.

There are distinguishable elements that separate a Legislative Enactment and the Executive Order.

**The first, being a Legislative Enactment** (a Bill) by the Assembly, Senate, and the signing of the Bill by the Governor. The Legislative Enactment

(the Bill) can carry beyond the point of the time limit that is imposed by the State of Emergency Act. The Legislative Enactment (the Bill) removes the ability of the Governor to unilaterally terminate the increased benefits without the approval of both Legislative Branches by the passage of Legislation to terminate or cease the Bill.

The umbrella of protection through a Legislative Enactment (the Bill) can be a significant continuation of benefits.

**The second is an Executive Order from the Governor** allows for automatic termination of benefits if the termination of benefits is directed by the Governor. The Governor cannot, unilaterally terminate benefits that were enacted by the Assembly and Senate and previously approved by the Governor (the Bill).

Yet, there are some very significant advantages to the Executive Order. The advantage to the Executive Order N-62-20 is the immediate implementation of same. Whereas, through the Legislative process (the Bill) can be tied up in small issues, and not move forward quickly to help the economic damages that have occurred and are occurring because of the Corona Virus attack.

There are certain employees (the Protectors) who are at risk in providing health and safety for their California populous. Assembly Bill 664 also needs to go forward to protect the Protectors. AB 664 does not force the Protector to use up their own benefits (sick leave) before commencement of Labor Code 4850, 4800 and 4800.5. ★

# Police Policies, Procedures & Politics

Over the last few weeks, our nation, state and county have been reeling from the collective outrage directed at Minneapolis police (and law enforcement generally) for the killing of African-American George Floyd. The early protests in response to the death of Mr. Floyd included widespread vandalism and looting, although such criminal acts have diminished over recent weeks.

This national unrest has resulted in a significant change of the public's perception of law enforcement and race relations. The Golden State has not been immune. Our governor, state legislators, congressional representatives and local electeds have all committed to take action to curtail various uses of force by law enforcement.

## CAROTID AND CHOKE HOLDS

Despite their differences, these techniques are largely viewed by the public as interchangeable terms that seek to accomplish the same goal - the incapacitation of a suspect. The governor recently ordered P.O.S.T. to stop teaching and training these holds. Numerous sheriffs, police chiefs, city and county leaders have followed suit, suspending or prohibiting the use of the holds.

The state legislature will vote to prohibit law enforcement agencies from authorizing the usage of these holds. The still-evolving proposed state legislation does not actually ban officers from using the holds. Some critics have asserted that the bill is designed to make civil suits against depart-

ments much easier to win if an officer were to use the hold. Officers could also be subject to department discipline for using the unauthorized techniques.

## RIGHT TO PROTEST - PEACEFULLY

The First Amendment to the Constitution of the United States of America prohibits government from limiting a citizen's right to free speech, peaceful assembly and to “petition the government for a redress of grievances.” The inclusion of peaceful is a pre-condition the Constitution imposes upon protesters - one that many lawmakers and pundits fail to recognize. When it comes to public protests, the government is barred from interfering in peaceful demonstrations. However, the Constitution confers no First Amendment right to non-peaceful, violent or destructive protesters.

## LESS-LETHAL OPTIONS

Some state and federal lawmakers are now proposing to limit the ability of law enforcement to protect the public by introducing legislation to ban the use of tear gas, rubber bullets and other less-lethal options. As mentioned above, these lawmakers fail to differentiate between peaceful and non-peaceful demonstrations. Current law already makes it illegal for the government to use force on peaceful protestors. Most folks don't want to

see our government going after peaceful demonstrators with tear gas, flash-bangs, rubber bullets, wood blocks, batons and other less-deadly alternatives.

In pursuing such restrictions on law enforcement's uses of force, lawmakers must face an over-riding and uncomfortable question: If these and other less-lethal options are banned, only lethal options will remain. The public was shocked to learn that a senior protesting police officer was blinded after being struck by a rubber bullet. I think most would agree that losing one's sight while peacefully protesting violence is not acceptable. Less lethal options have been developed for law enforcement use in response to complaints and perceptions that deadly force was being used more often than necessary because there were no intermediate options available. Banning such options will again limit officers to just two unacceptable choices: do nothing or use deadly force.

## QUALIFIED IMMUNITY

Another popular talking point and objective of the anti-cop crowd is the proposal to eliminate a legal doctrine recognized throughout our country. Qualified immunity essentially prevents officers from being held civilly liable for their official acts as long as those acts do not violate “clearly established statutory or constitutional rights.” Eliminating

qualified immunity would likely result in an explosion of costly nuisance lawsuits designed to enrich pro-criminal trial attorneys. Why should officers be forced to defend themselves against litigious criminal defendants in cases where no law was broken and no constitutional right violated? Critics of this approach have asserted that the true goal is to essentially “defund the police” through another means. If spurious claims were allowed to advance these claims would endlessly clog court operations while bankrupting our cities and counties.

**OTHER ANTI-COP PROPOSALS**

- Create statewide law enforcement prosecution unit consisting of civil and criminal rights advocates, empowering them to determine if and when charges against law enforcement officers should be filed and prosecuted
- Greatly increase the powers to law enforcement civilian review boards to include investigative powers and subpoena authority
- Expand public access to law enforcement body cam recordings

- Implement new crime akin to “aiding and abetting” and applicable only to peace officers
- Impose AB 392 use of force restrictions
- Establish a police reform/criminal justice advisory board to develop bill proposals

We will have our hands full as we work towards a united approach with our public safety brothers and sisters throughout the state, advocating to protect our members and the public.

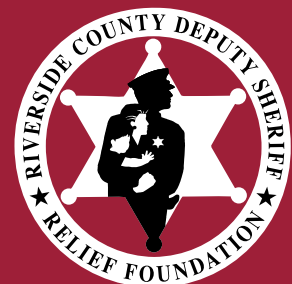


