SUMMARY ANNUAL REPORT

FOR RIVERSIDE SHERIFFS' ASSOCIATION LEGAL DEFENSE TRUST

This is a summary of the annual report of the Riverside Sheriffs' Association Legal Defense Trust, E.I.N. 33-6200313, Plan No. 501, for the year ended December 31, 2021. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$5,273,788 as of December 31, 2021, compared to \$5,356,998 as of January 1, 2021. During the plan year, the plan experienced a decrease in its net assets of \$83,210. This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$1,751,722 including employer contributions of \$1,411,568, realized loss of \$27,599 from the sale of assets and income from investments of \$367,753.

Plan expenses were \$1,834,932. These expenses included \$458,686 in administrative expenses and \$1,376,246 in benefits paid to or for participants.
