

## **SUMMARY ANNUAL REPORT**

### **FOR RIVERSIDE SHERIFF'S ASSOCIATION LEGAL DEFENSE TRUST**

This is a summary of the annual report of the Riverside Sheriff's Association Legal Defense Trust, E.I.N. 33-6200313, Plan No. 501, for the year ended December 31, 2018. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$4,195,391 as of December 31, 2018, compared to \$4,179,714 as of January 1, 2018. During the plan year, the plan experienced an increase in its net assets of \$15,677. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$1,395,756 including employer contributions of \$1,425,139, realized gain of \$54,625 from the sale of assets and loss from investments of \$84,008.

Plan expenses were \$1,380,079. These expenses included \$411,891 in administrative expenses and \$968,188 in benefits paid to or for participants and beneficiaries.

2. financial information and information on payments to service providers; and
3. assets held for investment.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan (21810 Cactus Avenue, Riverside, CA 92518) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
